Amendment of EC proposal as the ARRS report is not done MoEF & CC, Govt. of India guidelines. The details SEAC observation as follows:

- i) The KML file shows Lease area completely filled with water and no sand.
 - ii) RS carried out with thickness of 1.5 Mt without details elevation data of pre monsoon and post monsoon.
- The consultant Geomac in panel of ORSAC may be reviewed.

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
