After detailed deliberations SEAC recommended the proposal for Rejection of Terms of Reference and forwarded to SEIAA for rejection under the provision of EIA Notification, 2006 and as amended thereof.

The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Expert Appraisal Committee hereby decided to Reject Terms of Reference for instant proposal of M/s. SIDDHARTHA KONAR under the provisions of EIA Notification, 2006 and as amended thereof.
