detailed deliberations the authority decided “The authority observed that the SEAC have rejected the amendment of EC proposal under the violation proviosn as the project proponent has gone for excess production beyond the limit of EC. After detailed deliberation, the authority opined that this a case of violation of excess production made by the project proponent and decided that the environmental clearance granted by SEIAA vide letter no. 86/SEIAA dated 19.01.2021 is hereby revoked. Further, the amendment of EC application is rejected”.

3. Hence, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
