1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 175th Meeting of State Environment Impact Assessment Authority meeting held fromm 23/10/2024 to 24/10/2024. Based on the recommendations of the State Expert Appraisal

Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “After detailed deliberation, the authority accepted the recommendation of SEAC and rejected the amendment of EC application as the ARRS report is not acceptable due to following reasons:

1) In the KML file the lease area shown on a hill top which is devoid of sand and in approved mining plan, the location (Latitude & Longitude) do not coincide with the lease area of the KML file. Hence, the amendment of EC application is rejected.”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
