The Project Proponent submitted online Proposal No. **SIA/HR/IND1/465625/2024** dated **11.03.2024** for obtaining **Term of Reference (ToR)** under Category **3(a)** of EIA Notification dated 14.09.2006. The PP submitted the scrutiny fee of **Rs. 2,00,000/- vide DD No. 363339** dated **26.03.2024**.

1. ToR presentation for the same was done in SEAC, Haryana dated 29.03.2024 at Agenda Item No. **289.08** & MoM was published on 06.04.2024 stating "After due deliberations, the Committee decided that the case be sent to SEIAA for

taking further necessary action against the PP under Environment (Protection) Act, 1986 as it's have applied for Environment Clearance after the expiry of timeline provided by Ministry of Environment, Forests & Climate Change, GoI.”

2. In view of the above, the Ministry vide its recent notification S.O. 2215(E) dated 7th June, 2024 states that “for item 3 and entries relating thereto, the following item and entries shall be substituted, namely:- **“3(a) Metallurgical Industries (ferrous & nonferrous) - Category with threshold limit for Secondary Metallurgical Industry”**”

& (iii). The Standalone rolling or re-rolling or extrusion or piercing or forging or drawing units not involving any type of melting or pickling are exempted”.

The case of the PP now falls well within the new threshold limits and meets the criteria for exemption as stipulated in the recent notification. The project involves production facility of 18,300 TPA steel rolling mill& forging units with gas fuel or electricity operating with less than 30,000 TPA and pickling facilities, hence, the project is exempted from obtaining Environment Clearance.

DECISION OF THE AUTHORITY (SEIAA):

The case was taken up during the 180th meeting of SEIAA held on 10.08.2024. Upon perusal of relevant Notification dated 07-06-2024, the Authority decided to allow to withdrawal of the application in view of Notification S.O. 2215(E) dated 07-06-2024 issued by the Ministry of Environment, Forests & Climate Change, GoI.
