The SEIAA, in its meeting held on 19/11/2024 , based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in the point below.

The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. Verma Mining Solution under the provisions of EIA Notification, 2006 and as amended thereof.
6. Chhattisgarh accepted the recommendation of SEAC-1, Chhattisgarh and decided to delist/reject the applied case. SEIAA, Chhattisgarh also suggest to the project proponent to apply fresh application as per the notification/guidelines issued by MoEF&CC from time to time.
