4. The above-mentioned proposal has been considered by SEIAA in the meeting held on 24/04/2024. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above.
 5. The SEAC, based on information submitted viz: Form 1 (Part A, B) report etc., & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and public hearing issues and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
 6. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEAC hereby accords Environment Clearance for the instant proposal to Thiru.SUBRAMANIAN SATHISH under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)

11. General Instructions:

- The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
- The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
- The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.
- Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
- Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
- Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Specific EC Conditions for (Mining Of Minerals)

1. Seac Conditions - Site Specific

S. No	EC Conditions
1.1	<p>1) Tree plantation & fencing and installation of garland drainage with siltation tank around the mine lease area shall be completed before execution of the mine lease.</p> <p>2) The PP shall mark the DGPS reference pillars painted with blue & white colour indicating the safety barrier of 7.5 m to be left under the Rule 13 (1) of MCDR, 1988 within the lease boundary and protective bunds, before obtaining the CTO from the TNPCB.</p> <p>3) The PP shall register promptly through online in the Shram Suvidha Portal which is the official portal of Ministry of Labour & Employment, Govt of India to obtain Labour Identification Number (LIN) before obtaining the CTO from the TNPCB.</p> <p>4) As accepted by the Project Proponent the CER cost is Rs. 5 Lakhs and the amount shall be spent towards Government Higher secondary School, Munnirpalayam Village for the activities as committed before obtaining CTO from TNPCB.</p> <p>5) The PP shall not employ any external agency for carrying out the blasting operation and he shall also install the temporary magazines approved by the concerned licensing authority before the execution of the lease, for storing the authorized explosives & detonators separately in accordance with the Explosive Rules, 2008.</p> <p>6) Since the structures are situated within a radial distance of 500 m, the PP shall carry out only one blast per day with muffle technique, for not more than 30 to 40 holes in a round, with maximum charge of 375g/hole.</p> <p>7) However, after obtaining the prior permission from the DMS/Chennai Region, the PP shall carry out the scientific studies within a period of six months from the commencement of quarrying operations, to design the controlled blast parameters for reducing the blast-induced ground/air-vibrations and eliminating the fly rock from the blasting operations carried out in the quarry, by involving anyone of these reputed Research and Academic Institution such as CSIR-Central Institute of Mining & Fuel Research / Dhanbad, NIRM/Bangalore, IIT-Madras, NIT-Dept of Mining Engg, Surathkal, and Anna University Chennai-CEG Campus. A copy of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</p> <p>8) Since the villages & sensitive structures are located within 500 m, as a part of monitoring the implementation of eco-friendly blasting operation, the PP shall monitor the blast-induced ground & air vibration (noise) by installing the DGMS approved ‘Vibration Monitoring System (VMS)’ at a distance of 200m, 300m, and 500 m and the fly rock level produced through capturing a video image once in six months, by involving any of the reputed Research and Academic Institution such as CSIR-Central Institute of Mining & Fuel Research / Dhanbad, NIRM/Bangalore, IIT (ISM) -</p>

	<p>Dhanbad, and Anna University Chennai-CEG Campus, etc. A copy of such post-monitoring report shall be submitted to the AD/Mines-DGM, Director of Mines Safety / Chennai Region, the SEIAA-TN, and the IRO/MoEF, as a part of Environmental Compliance without any deviation.</p> <p>9) Since more waterbodies are situated nearby, the PP shall annually carry out the scientific studies to assess the hydrogeological condition of the quarry after the commencement of mining operations for ensuring the safety of the persons working in the mine and to determine impacts of the mining operation on the ground water conditions in the waterbodies, by involving any one of the reputed Research and Academic Institution - CSIR-Central Institute of Mining & Fuel Research / Dhanbad, NIRM/Bangalore, Division of Geotechnical Engineering-IIT-Madras, NIT-Dept of Mining Engg, Surathkal, University of Madras – Centre for Environmental Studies, and Anna University Chennai-Dept of Geology, CEG Campus. A copy of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai Region as a part of Environmental Compliance without any deviation.</p> <p>10) The PP shall ensure that the transportation of minerals shall not be carried out through the village road passing near the school premises.</p> <p>11) The PP shall appoint a statutory Mine Manager possessing the I / II Class Mines Manager Certificate of Competency (R/UR) under MMR 1961 before executing the lease and a copy of such appointment shall be sent to the DMS/Chennai Region atleast 30 days before the commencement of the mining operations without fail.</p> <p>12) The PP shall not carry out the deep hole larger diameter blasting and the secondary blasting of oversize fragments /boulders during the life of the lease period.</p> <p>13) At the time of lease execution, the PP shall submit a Slope Stability Action Plan with leaving a safety berm of not less than 15 m for the highwall benches currently standing without proper benching formation of 18 m height in the quarry and it shall be adequately fence off with safety bund/embankment of not less than 1 m height to prevent inadvertent entry of persons.</p> <p>14) For the safety of the persons employed in the quarry, after obtaining prior permission from the DMS/Chennai Region, the PP shall carry out the scientific studies to assess the slope stability of the working benches and existing quarry walls within a period of six months from the commencement of mining operations for evaluating the slope stabilization & protective measures while designing the proposed benches, by involving any one of the reputed Research and Academic Institutions - CSIR-Central Institute of Mining & Fuel Research / Dhanbad, NIRM/Bangalore, Division of Geotechnical Engineering-IIT-Madras, NIT-Dept of Mining Engg, Surathkal, and Anna University Chennai-CEG Campus. A copy of such scientific study report shall be submitted to the SEIAA, MoEF, TNPCB, AD/Mines-DGM and DMS, Chennai as a part of Environmental Compliance without any deviation.</p> <p>15) The PP shall furnish an affidavit indicating the Standard Operating Procedures (SoP) for carrying out the ‘Best Mining Practices’ in the areas of drilling, blasting excavation, transportation and green belt development, in securing the safety of the persons living within a radial distance of 500 m (danger zone) to the concerned AD (Mines) at the time of lease execution.</p>

Efforts shall be made to utilize gypsum generated from Flue Gas Desulfurization (FGD), if any, along with fly ash for external dump of overburden, backfilling of mines. Compliance report shall be submitted to Regional Office of MoEF&CC, CPCB and SPCB.
6.4	A separate team for subsidence monitoring and surface mitigation measures shall be constituted and continuous monitoring & implementation of mitigation measures be carried out.
6.5	Native tree species shall be selected and planted over areas affected by subsidence.
6.6	The project proponent shall make necessary alternative arrangements, if grazing land is involved in core zone, in consultation with the State government to provide alternate areas for livestock grazing, if any. In this context, the project proponent shall implement the directions of Hon'ble Supreme Court with regard to acquiring grazing land.


