The name of the PP in the application is Sunil Kumar Singh but LoI and Cluster Certificate has been obtained in the name of M/s. Bhagel Infraprojects Pvt. Ltd. After detailed deliberations, SEAC recommended the proposal for Rejection of Environment Clearance and forwarded to SEIAA for rejection under the provision of EIA Notification, 2006 and as amended thereof.

The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the State Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. SUNIL KUMAR SINGH under the provisions of EIA Notification, 2006 and as amended thereof.
