1. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-1(Part A and B) were submitted to the Ministry for an appraisal by the Expert Appraisal Committee SEIAA in the Ministry under the provision of EIA notification 2006 and its subsequent amendments.
2. The above-mentioned proposal has been considered by Expert Appraisal Committee of SEIAA in the meeting held on 03/10/2024. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

3. The brief about configuration of plant/equipment, products and byproducts and salient features of the project along with environment settings, as submitted by the Project proponent in Form-1 (Part A and B) presented during SEIAA are annexed to this TOR as Annexure (1).
4. The SEIAA, in its meeting held on 03/10/2024, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Terms of Reference under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in the point below.
5. The SEIAA has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided Rejection Terms of Reference for instant proposal of M/s. SURYAKANT SINHA under the provisions of EIA Notification, 2006 and as amended thereof.
6. The Committee (SEAC, Chhattisgarh) found that, application has applied in the name of Mr. Suryakant Sinha but in all the documents (like Modified Mining plan, Lease deed, 500 meter cluster certificate etc.) proponent's name is Shri Paras Ram Sinha. Hence, committee recommended to return this application in the present form and apply a fresh application as per notification/ Office Memorandum issued by MoEF&CC from time to time.
7. SEIAA, Chhattisgarh accepted the recommendation of SEAC, Chhattisgarh and decided to delist/reject the applied case. SEIAA, Chhattisgarh also suggest to the project proponent to apply fresh application as per the notification/guidelines issued by MoEF&CC from time to time.
