

The SEIAA, AP vide reference 1st cited issued EC order to the 2.0 Ha, Colour Granite Mine at Sy.No.444 of Gundlapalle Village, Thamballapalle Mandal, Annamayya District (Erstwhile Chittoor District), Andhra Pradesh in favour of M/s. Y.S.R Enterprises for mining of Colour Granite – 2,500 m³/Annum.
- II. Sri Suresh Kothari vide reference 3rd cited requested for Transfer of EC from M/s. Y.S.R Enterprises to Sri Suresh Kothari.
- III. The Divisional Mines & Geology Officer, Madanapalle, vide Procd. No. 1285/TQL/CG/2023, Dt. 31.05.2024 transferred the quarry lease from M/s. Y.S.R Enterprises to Sri Suresh Kothari.
- IV. M/s. Y.S.R Enterprises (Prop:Sri.Y. Sree Ram) has submitted the NOC for transfer of EC in favour of Sri Suresh Kothari.
- V. The issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) in its meeting held on 06/01/2025, and decided to transfer EC from M/s. Y.S.R Enterprises to Sri Suresh Kothari subject to submission of Undertaking by the transferee on Rs.100/- Non-judicial stamp paper in the prescribed format.
- VI. Accordingly, the SEIAA raised ADS on 16/01/2025 and the Transferee (Sri Suresh Kothari) submitted the Undertaking in prescribed format on 10/03/2025.

VII. The SEIAA, AP., hereby transfers the Environmental Clearance in the name of Sri Suresh Kothari with all terms and conditions stipulated in the EC order issued vide reference 1st cited remains the same.
