1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha (SEIAA, Odisha) in 196th meeting held on 19/04/2025 to 19/04/2025. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after

detailed deliberations the authority decided “After detailed deliberation, the authority decided to reject the amendment of EC as recommended by SEAC due to the following reasons:

1. The quarry production for FY 2022 – 2023, FY 2023 – 2024 and FY 2024 – 2025 (Till January 2025) to be ascertained from the concerned Mining officer In-charge for ensuring compliances with the EC condition.
2. It needs to be ascertained if satisfactory annual replenishment study reports of sand was submitted by the PP during FY 2022 – 2023 and FY 2023 – 2024 as compliance of conditions stipulated in the EC grant order.
3. The replenishment study is not proper as the pre- and post-monsoon drone surveys have not been carried out as per the ORSAC SOP stated above.”
3. Hence, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
