Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided "After detailed deliberation, the authority accepted the recommendation of SEAC and rejected the amendment of EC application as the ARRS report is not acceptable as no error statement is given while calculating the pre-monsoon standard elevation and post-monsoon elevation."

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
