1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered in 176th Meeting of State Environment Impact Assessment

Authority meeting held from 29/10/2024 to 30/10/2024. Based on the recommendations of the State Expert Appraisal Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the Authority decided “After detailed deliberations, the Authority rejected the Amendment of EC application with following reasons: i) EC is in favour of Tahasildar but amendment of EC application has been made by the successful bidder without transfer of EC in his favour. As per the Mining Plan and KML file, the lease area it is coming within the Latitude of 19 °10' 59.88"N & longitude- 82°27'30.26"E but the GCPs marked in the field and DGPS Co-Ordinates taken during ARRS study with the co-ordinates coming in Latitude of 9°25'36.16894” N & longitude82°19'24.98652’’E. Both KML file of the coordinate and ARRS study area are different.”

Therefore, the proposal for Amendment in EC is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
