In view of the particulars given in the Para 1 above, the project proposal interalia including Form-7 were submitted to the SEIAA under the provision of Para 11 of the EIA notification 2006 and its subsequent amendments. Details in Form 7 can be accessed on PARIVESH portal by scanning the QR Code above.
4. The project proponent (PP) has applied proposal for transfer of EC from the name Tahasildar, Kotpad to Sri Tushar Bisoi, (highest bidder/lessee) with attaching NOC from Mining Officer, Koraput issued vide letter no. 306 dated 16.02.2024.
5. The matter was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 157<sup>th</sup> meeting held on 22.02.2024. The SEIAA, Odisha has examined the requisite information/documents required for transfer of EC in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and hereby accords Transfer of EC dated to Sri Tushar Bisoi under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions issued vide EC letter no./EC Identification No. 9958/SEIAA dt. 09.12.2020.
6. The SEIAA, Odisha may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory. The SEIAA reserves the right to stipulate additional conditions, if found necessary.
7. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of the prior EC issued vide letter no. 9958/SEIAA dt. 09.12.2020.
8. The Project Proponent shall be uploaded/submitted six monthly EC compliance in the PARIVESH Portal of MoEF & CC., Govt. of India only from date of issue of transfer of EC, falling which the EC stands automatically revoked.
9. In case, there is a change in the scope of the project, fresh Environment Clearance shall be obtained.

#### **Additional EC Conditions**

1. Boundary Demarcation: - The boundary of the lease area shall be demarcated on ground at the project cost, by erecting 1.20 meter (4 feet approx.) high reinforced concrete pillars above ground, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates by any empanelled agency of ORSAC.
2. Digital Map: -A digital map (in KML format as well as PDF version) showing GPS coordinates of all boundary pillars duly countersigned by the concerned Mining Officer/Tahasildar shall be submitted to SEIAA, Odisha through email at [info.seiaaodisha@gmail.com](mailto:info.seiaaodisha@gmail.com).
3. Intimation of EC: -The copies of the EC shall be sent to the Sarpanch (s) of the concerned Gram Panchayat (s), Urban Local Bodies and relevant other Offices of the Government with a request to display the same for 30 days from the date of receipt.
4. Tree Plantation:-Compensatory Tree Planting (CTP) shall be carried out with minimum @100 trees per Ha. of lease

area as per the approved cost norm for avenue plantations of the State Forest Department. The Project Proponent (lease holder) shall deposit Rs.2,50,000/- with the respective District Environment Society for raising 500 plants of native species within 2 years in a suitable location adjoining to quarry.

5. The PP has to expend the EMP cost as submitted in their EMP report during EC application.
