EXTENSION OF VALIDITY OF ENVIRONMENTAL CLEARANCE

Preamble:

Attention is invited to this Authority's letter No. SEIAA 404 MIN 2019 dated 16.07.2019 and Extension of validity of EC dated 13.10.2021 and Transfer of EC dated 07.12.2024 regarding the granted of Environmental Clearance for Pink Granite Quarry Project at Sy.No.78 of Yelakarallahalli Village, Gudibande Taluk, Chikkaballapura District (10-00 Acres) to Sri Usharani P.

Further, Project Authorities have requested vide online application bearing proposal No. SIA/KA/MIN/487322/2024 dated 11.07.2024 for Extension of Validity of EC.

The State Expert Appraisal Committee (SEAC) considered the proposal during the meeting held on 26th, 30th & 31st December 2024. The Committee as per the provision in MOEF&CC OM dated 13.12.2022, after discussion decided to recommend the proposal to SEIAA to grant extension of validity of EC, till 15.07.2049 or till the validity of lease which ever is earlier with all other conditions remaining same as per the EC issued by SEIAA on 13.08.2019, with following consideration,

1. To grow trees all along the approach road & buffer zone during the first year of operation.
2. To carry out regular health checkup for the workers in the nearby Hospital.
3. To provide metal sheet fencing around the working area.
4. To take necessary measures to arrest noise and vibration from the quarry area.
5. To consider the CER activity submitted by Proponent with a recommendation to write to the concerned recipient about the CER activity.

The Authority have considered the proposal during the meeting held on 16th December 2024 and decided to extend the validity of EC till 15.07.2049 or till the validity of lease whichever is earlier with all other conditions remaining same as per the EC issued by SEIAA on 16.07.2019.

Hence the order.

ORDER

Pursuant to the facts and circumstances in the preamble, the validity of the Environmental Clearance issued vide letter No. SEIAA 404 MIN 2019 dated 16.07.2019 Transfer of EC vide letter dated 07.12.2024 in favour of Smt. P. Usharani W/o Late Palaniswamy, No. 707, Konar Palyam, Allapalayam, Annur, Coimbatore, Tamil Nadu - 641 653 by the State Level Environment Impact Assessment Authority, Karnataka for the Quarrying of "Pink Granite", in an extent of 10-00 Acres of Govt. Kharab Gomala Land bearing Sy. No. 78 of Yelakarallahalli Village, Gudibande Taluk, Chikkaballapura District, Karnataka stands extended till 15.07.2049 or till the validity of lease which ever is earlier with all other conditions remaining same as per the EC issued by SEIAA on 16.07.2019 shall be adhered with following conditions.

1. The PP shall grow trees all along the approach road & buffer zone during the first year of operation.
2. The PP shall carry out regular health checkup for the workers in the nearby Hospital.
3. The PP shall provide metal sheet fencing around the working area.
4. The PP shall take necessary measures to arrest noise and vibration from the quarry area.
