1. In view of the particulars given in the Para 1 above, the project proposal interalia including Application for Amendment in EC- Form-4 were submitted to the SEAC, Odisha for an appraisal by the State Expert Appraisal Committee (SEAC) under the provision of EIA notification 2006 and its subsequent amendments.

2. The above-mentioned proposal has been considered by State Environmental Impact Assessment Authority, Odisha (SEIAA, Odisha) in 190th meeting held on 01/03/2025. Based on the recommendations of the State Expert Appraisal

Committee, Odisha (SEAC, Odisha), information & clarifications provided by the project proponent and after detailed deliberations the authority decided “After detailed deliberation in the matter, the authority accepted the recommendation of SEAC and decided to reject the proposal due to the following reasons as pointed out by SEAC:

- i. Production of the riverbed sand during FY 2023 – 2024 and FY 2024 -2025 (Till December 2024) to be ascertained by the Mining Officer In-charge for ensuring compliance with the EC conditions.
  - ii. The pre and post monsoon photogrammetry surveys using drones/UAV are not carried out as per the standard operating procedure (SOP) for study of rate of replenishment of sand using drone survey prepared by ORSAC for SEIAA, Odisha and submitted vide letter No. ORSAC/PR/0951/21/2588 dated 02nd June 2023. Hence the replenishment study report is not accepted. The PP shall submit revised ARRS report.’’
3. Hence, the proposal is Rejected as per provision of EIA Notification, 2006 and as amended thereof.
