

- I. The SEIAA, AP vide reference 1<sup>st</sup> cited issued EC order to the 1.597 Ha, Colour Granite Mine of Sri V. Lokesh, Sy.No:68/2, Bevanpalli Village, Kuppam Mandal, Chittoor District, Andhra Pradesh for mining of Colour Granite – 4529.25 m<sup>3</sup>/annum.
- II. Sri S. Venkatesh, vide reference 3<sup>rd</sup> cited requested for transfer of EC from Sri V. Lokesh to Sri S. Venkatesh.
- III. The Divisional Mines & Geology, Palamaneru, vide Procd. No. 1812/TQL/CG/2022, dt. 25.04.2024 transferred the quarry lease from Sri V. Lokesh to Sri S. Venkatesh.
- IV. Sri V. Lokesh has submitted the NOC for transfer of EC in favour of Sri S. Venkatesh through online.
- V. The issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) in its meeting held on 06.01.2025, and decided to transfer the Environmental Clearance from Sri V. Lokesh to Sri S. Venkatesh subject to submission of undertaking by the transferee on Rs.100/- Nonjudicial stamp paper in the prescribed format enclosed.
- VI. Accordingly, the SEIAA raised ADS on 16.01.2025 and the transferee (Sri S. Venkatesh) submitted the Undertaking on Rs.100/- Non-judicial stamp paper on 24.01.2025.
