1. SEIAA, Chhattisgarh in its 186th Meeting held on 25/02/2025 perused the application submitted by the project proponent and minutes of the 554th meeting of SEAC-2 held on 24/01/2025. It is noted that No representative was present for the presentation. Project Proponent informed vide their letter dt. 24/01/2025 that some mistake has been happened during filling the application. Project proponent requested the committee to delist this case. The request has been approved by the committee. SEIAA, Chhattisgarh unanimously accepted the

The SEIAA, in its meeting held on 25/02/2025 , based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for Rejection of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of specific and general conditions as detailed in the point below.

The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. VIJAY JAIN under the provisions of EIA Notification, 2006 and as amended thereof.
