



In inviting a reference to the above cited subject, I am directed to inform you that the proposal was placed in the meeting of SEIAA held on 03.06.2024 for consideration of Transfer of EC. The authority observed that there is no approval letter from the competent authority for EC and there is no valid excise license in his favour. The EC granted vide SEIAA letter no. 5414/SEIAA dt. 28.07.2018 in favour of earlier PP has expired. After detailed deliberation in the matter, the authority decided to reject the transfer of EC application since there is no provision for transfer of an EC which has already been expired.
