The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. Sri M Kumar under the provisions of EIA Notification, 2006 and as amended thereof.

M/s. SRK Exports applied vide Proposal No. SIA/TG/MIN/457779/2024 seeking Transfer of Environmental Clearance from M/s. Sahana Granites to M/s. SRK Exports.

The issue was placed before the State Level Environment Impact Assessment Authority (SEIAA), Telangana in its meeting held on 09.07.2024 and the Authority observed as follows:
