

**Sub: SEIAA, A.P. – 1.102 Ha, Barytes Mine of Sri Basha Syed Sajjad (Smt. S. Raflunnissa Begum) at Sy Nos. 230 & 211/A of Velpula Village, Vemula Mandal, YSR Kadapa District, A.P.– Amendment to Environmental Clearance – Rejection - Reg.**

2. Your application dated 03/09/2024 for Amendment EC vide proposal No.SIA/AP/MIN/494224/2024.

- I. The SEIAA, AP had issued Environmental Clearance vide reference 1<sup>st</sup> cited to the 1.102 Ha Barytes Mine of Smt. S. Raflunnissa Begum at Sy Nos. 230 & 211/A of Velpula Village, Vemula Mandal, YSR Kadapa District, Andhra Pradesh with production capacity of Barytes – 1500 TPA. This order is valid for a period of 20 years or the expiry date of mine lease period issued by the Government of A.P., whichever is earlier.
- II. In the reference 2<sup>nd</sup> cited, you have submitted an application through online on 03/09/2024 seeking Amendment to Environmental Clearance.
- III. Accordingly, the request of the proponent was examined by the State level Expert Appraisal Committee (SEAC) in its meeting held on **05.12.2024**.

The authorized person of the project and their consultant M/s. Ecomen Mining Pvt Ltd., labs have attended the meeting and presented the proposal.

The SEAC committee noted that the project proponent has applied for amendment of Environmental Clearance instead of Transfer of EC and committee directed the project proponent to apply for transfer of Environmental clearance to change name of the mine lease. Hence, committee rejected the amendment of Environmental clearance proposal.

The Committee after examining the project amendment proposal, presentations, MoEF&CC Notifications & OMs and detailed deliberations, recommended to reject the Amendment of Environmental clearance proposal.

- IV. The issue was placed before the SEIAA in its meeting held on **03.01.2025**. The SEIAA agreed with the recommendations of the SEAC to **reject** the Amendment to EC proposal.
- V. In view of the above, **your application for Amendment to Environmental Clearance is here by REJECTED**. No mining / construction / expansion or development of work shall be carried out without obtaining Environmental Clearance as per the provisions laid under E(P) Act, 1986 and EIA Notification 2006 dt.14.09.2006 and its amendments thereof.
- VI. Any appeal against this order shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
