This is in reference to your application submitted to SEIAA vide proposal number SIA/CG/MIN/502486/2024 dated 23/10/2024 for grant of prior Environmental Clearance (EC) to the project under the provision of the EIA Notification 2006-and as amended thereof.

SEIAA in its 191th Meeting held on 24/04/2025 perused the case and minutes of the 563rd meeting of SEAC-1 held on 06/02/2025. It is noted that original application is for mining of Ordinary Stone (Minor Minerals) capacity - 13,716.3 TPA. After deliberation, SEIAA unanimously accepted the recommendation of SEAC-1 and decided to grant environmental clearance for mining of Ordinary Stone capacity 13,716.3 TPA (maximum production quantity according to mining plan) in Kharsa No. 369/51, area - 1.088 Ha. of Village - Bankipur, Tehsil - Ambikapur, District– Surguja,

Chhattisgarh subject to the submission of following additional documents:-

1. PP shall submit the consent of the headmaster of school for CER work.

With reference to the above, Project proponent has submitted the consent of the headmaster of Government Middle School, District- Surguja for CER work on 03.06.2025.

3. Environment Clearance is for mining of Ordinary Stone capacity 13,716.3 TPA (maximum production quantity according to mining plan) in Kharsa No. 369/51, area - 1.088 Ha. of Village - Bankipur, Tehsil - Ambikapur, District – Surguja Chhattisgarh.
4. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-2 (Part A and B)/ EMP Reports were submitted to the SEIAA for an appraisal by the SEIAA under the provision of EIA notification 2006 and its subsequent amendments.
5. The above-mentioned proposal has been considered by SEIAA in the meeting held on 24/04/2025. The minutes of the meeting and all the project documents are available on PARIVESH portal which can be accessed from the PARIVESH portal by scanning the QR Code above. Brief description of the project is as under:
6. Details of the minerals to be mined along with production capacity and the brief on the salient features of the project as submitted by the project proponent in Form 1 (Part A and B) in the reports and as presented during SEIAA are annexed to this EC as Annexure (1).
7. The SEIAA, in its meeting held on 24/04/2025, based on information submitted viz: Form 1 (Part A and B), EIA/EMP report etc & clarifications provided by the project proponent and after detailed deliberations on all technical aspects and compliance thereto furnished by the Project Proponent, recommended the proposal for grant of Environment Clearance under the provision of EIA Notification, 2006 and as amended thereof subject to stipulation of Specific and Standard EC conditions as detailed in the point below.
8. The SEIAA has examined the proposal in accordance with the provisions contained in the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and based on the recommendations of the SEIAA hereby accords Environment Clearance for the instant proposal to Mr. Chirag Chopra under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of the Specific and Standard EC conditions as given in Annexure (2)
9. The Ministry reserves the right to stipulate additional conditions, if found necessary.
10. The Environmental Clearance to the aforementioned project is under provisions of EIA Notification, 2006. It does not tantamount to approvals/consent/permissions etc. required to be obtained under any other Act/Rule/regulation. The Project Proponent is under obligation to obtain approvals /clearances under any other Acts/ Regulations or Statutes, as applicable, to the project.
11. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of this EC.
12. General Instructions:
 1. The project proponent shall prominently advertise it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days indicating that the project has been accorded environment clearance and the details of SEIAA website where it is displayed.
 2. The copies of the environmental clearance shall be submitted by the project proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn must display the same for 30 days from the date of receipt.
 3. The project proponent shall have a well laid down environmental policy duly approved by the Board of Directors (in case of Company) or competent authority, duly prescribing standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions.

4. Action plan for implementing EMP and environmental conditions along with responsibility matrix of the project proponent (during construction phase) and authorized entity mandated with compliance of conditions (during operational phase) shall be prepared. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Six monthly progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six-Monthly Compliance Report.
 5. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
 6. The Regional Office of this SEIAA shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
 7. Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

The maximum depth of mining should be kept to above the ground water. 11. The PP shall ensure that the mine's contaminated water should not go directly to nearby water body, make garland drain and silting ponds at required places for arresting the silt before mine water go to nearby nallah. The desilting of silting ponds should be done regularly. 12. Adequate sanitation, waste management system should be developed including construction of soak pits and safety tanks. 13. The PP shall submit the permission from competent authority for use of water and should install the measuring instrument for consumption of water and maintain logbook for it. 14. The PP shall make arrangement for energy conservation and promote the use of non-conventional energy like solar lights. 15. Personal protective equipment like dust mask, ear plug should be issued to workers who are exposed to dust and noise pollution beyond it's permissible limit. 16. In case of part of cluster mines, The PP shall contribute his share in executing the common EMP. 17. The CER Plan should be implemented within one year and it should be operated and maintained till the mine closure plan is implemented. 18. The report shall be submitted to the SEIAA, C.G./ SEAC, C.G. 2. The Ambient Air Quality monitoring in the core zone shall be carried out. The project authorities must strictly adhere to the stipulations made by the State Pollution Control Board and the State Government. 8. No further expansion or modifications in the plant shall be carried out without prior approval of the Ministry of Environment, Forests and Climate Change (MoEF&CC). 9. Concealing factual data or submission of false/fabricated data may result in revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986. 10. The Ministry may revoke or suspend the clearance, if implementation of any of the above conditions is not satisfactory. 11. The Ministry reserves the right to stipulate additional conditions if found necessary. The Company in a time bound manner shall implement these conditions. 12. The Regional Office of this Ministry shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/ monitoring reports. 13. 
