The MoEF&CC has examined the proposal in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee hereby decided to Reject Environment Clearance for instant proposal of M/s. ku sangeeta singh under the provisions of EIA Notification, 2006 and as amended thereof.
