

The project proponents should submit, PPT, EIA/EMP, Executive Summary, Public Hearing proceedings and queries subsequently raised by the Ministry, if any including details of the court matters/Orders of the Court pertaining to the project if any, in original, duly signed by the company authorized signatory for Environmental Clearance, in hard form to the Ministry.
- 6. Hardcopies of the DPR or the detailed EIA, EMP, etc. need not be sent to the EAC members. The project proponents should submit only an Executive Summary (it should not normally exceed 25 pages) along with PPTs in hard form to EAC members.
- 7. For the proposals from the Private Sector Organizations, Director or above level and for proposals from the Government, the Chief Engineer concerned or above level

- officer/s should lead the team. Officers should come and respond to explain the project and respond to queries from the Committee Members.
- 8. Mobile Phone should be kept on switched off/silent mode during the meeting.
- 9. In addition to the above information, an affidavit/undertaking is required to be submitted by the Project Proponent to the Ministry to the effect, namely:




